Sponsorship Fee

Once you have registered as an Official State Finalist, there is a sponsorship fee. This sponsorship covers your activities for the duration of the pageant weekend, including a Pre-Pageant Orientation, which will be held approximately 5 weeks prior to the pageant weekend. (additional information to follow), an incredible 2-day/1-night hotel stay, meals, prizes, awards, and of course sending our new titleholders to the national 2024 MISS USA® and the MISS TEEN USA® pageants!

The sponsorship program can provide you with an opportunity to enter this pageant at little or no cost to yourself or your family. Your sponsorship may come from businesses, civic clubs, neighbors, family and friends. You may have as many sponsors as you wish, or you can even sponsor yourself.

The sponsorship is \$1195.00 and it is not due now. You will receive a digital Sponsorship Packet via email that includes sponsorship guidelines, specific details, access to forms that will help you obtain your sponsorship and your specific due dates. As an added incentive for our new contestants, you will receive a \$100 discount off the entire fee, bringing your total amount due down to \$1095, if you submit the total amount of your sponsorship on or before your first installment deadline*. Ample time will be provided for you to secure your sponsorship.

Pageant Wardrobe:

Check-In & Rehearsal Attire: Each contestant will need rehearsal clothing (sweats, sweatshirts, tennis shoes, etc.), and a business casual outfit for registration.

Private Interview: An outfit that represents your personality and you feel comfortable in. This can range from casual to business oriented, but something you would find in your own closet.



Show Opener: TEEN: Cocktail dress in any shade of pink | MISS: Black, silver or gold cocktail dress.



Evening Gown: All contestants must have a full-length evening gown for competition. Teens are encouraged to wear gowns that reflect a more youthful style, while Miss contestants are encouraged to wear gowns that reflect a more sophisticated style.



Swimsuit (MISS ONLY): Miss contestants may choose between a one or two-piece black swimsuit. Embellishments permitted. Adequate coverage is required. *No thongs or strings allowed*.



*Contestants are eligible for one discount only. Registration & Sponsorship discounts cannot be combined

Activewear (TEEN ONLY): Teen contestants will be competing in activewear. Capri style athletic pants or shorts are required. Sports bra or full length athletic style workout top required. Sleeves (cap or full) are not permitted. All black attire required.
